## CAMDEN COUNTY TECHNICAL SCHOOL SEWAGE PUMPING STATION REHABILITATION PROJECT

The project includes replacement of the sewage pumps (2) and associated valves and piping construction project within the Camden County Technical School property located at the Gloucester Township Campus at 343 Berlin Cross Keys Road within Gloucester Township, Camden County, New Jersey. The major construction items include 2 sewage pumps replacement construction, associated valves and piping replacements, new control panel to be mounted above the station, wet well cleaning, pump station floor concrete repair and other incidental work appurtenant thereto as shown in the plans and specifications. There is also a sewer force main extension (approximately 200 feet of 6-inch ductile iron) and a sewer gravity line extension (approximately 100 feet of 4-inch ductile iron) as shown on the plans. The anticipated construction schedule is to be during July 2013. A pre-bid meeting is scheduled for May 20 at 12:30 PM at the Administration Building on the Gloucester Township Campus. No questions will be accepted after May 22, 2013.

Specifications and forms of bids for the proposed work, prepared by Christopher B. Jepson, P.E., Engineer, of the firm of Van Cleef Engineering Associates, have been filed in the office of said Engineer at 4 AAA Drive, Suite 102, Hamilton, New Jersey 08691, and may be inspected by prospective bidders during business hours. Bidders will be furnished with a copy of the drawings and Specifications by the Engineer.

Bids <u>must</u> be made on standard proposal forms in the manner designated therein, and required by the specifications, must be enclosed in sealed envelopes, bearing the name and address of the bidder and the name of the project on the outside, addressed to **Mr. James Clark, Business Administrator, Camden County Technical School, Gloucester County Campus, 343 Berlin - Cross Keys Road, New Jersey 08081** and must be accompanied by a Non-Collusion Affidavit and a Bid Bond or Certified Check for not less than ten percent (10%) of the amount bid, providing said check or bid bond need not be more than \$20,000.00 nor shall not be less than \$500.00, and be delivered at the place on or before the hour named above. All surety bonds must be written by surety companies listed on the Federal Treasury List, Department circular 570 (N.J.A.C. 7:22-3.17(g)).

Bidders are required to conform to all provisions of the Local Public Contracts Law, the Prevailing Wage Act and the requirements of P.L. 1975, c.127. The Camden County Technical Schools reserves the right to reject any or all bids and to waive any informality in any bid inuring to the benefit of the School.
