A Pre-Proposal Conference/Site Visit is scheduled for **January 23, 2018 at 11:30 a.m.** on Blackwood Campus, Connector Building Room 101. Prospective vendors are highly encouraged to attend. Proposals must be submitted to the Purchasing Department, **Roosevelt Hall, Building #6, Room 135**, Camden County College, 200 College Drive, Blackwood, NJ 08012. The deadline for receipt of proposals is **2:00 p.m. on February 22, 2018**. Any proposals received after said deadline, whether by mail or otherwise, will be returned unopened. No proposals will be accepted after the above-referenced date. Proposals must be submitted in sealed envelopes with the name of the RFP clearly marked on the outside of the envelope. Proposals may not be faxed or transmitted over the telephone.

The College assumes no responsibility for delays in any form of carrier, mail or delivery service causing the proposal to be received by the Purchasing Department later than the above-referenced scheduled deadline.

Nothing herein is intended to exclude any responsible firm or in any way restrain or restrict competition. All responsible firms are encouraged to submit proposals. Final selection of firm(s) shall be made by the Camden County College Board of Trustees by formal resolution.

The College reserves the right to accept or reject any or all proposals submitted in the best interest of the College in accordance with the law. The College further reserves the right to waive any defect or informality in any proposal should it be in the best interest of the College. Proposers are required to comply with the requirements of P.L. 1975, c. 127 (N.J.A.C. 17:27) and P.L. 77, c. 33.

This Request for Proposals is a fair and open process to obtain competitive proposals from which the College may choose contractors that best meet the College's needs based on the evaluation criteria included within the specifications. The College intends to award any contract for these services pursuant to N.J.S.A. 18A:64A-25.5(a)(7) in accordance with the law.

All respondents must comply with P.L. 2009, c.315 and must submit a copy of the NJ Business Registration Certificate that is issued by the NJ Department of Treasury/Division of Revenue with the Request for Proposal.
