

**INVITATION TO BID  
SPECIFICATION #18-10B**

Pursuant to Section 40A:11-5(3) of the New Jersey Local Public Contracts Law and Resolution #18:8-122 the Camden County Municipal Utilities Authority (CCMUA), County of Camden, State of New Jersey hereby invites interested vendors to submit sealed bids for **SUPPLY AND DELIVERY OF BULK LIQUID OXYGEN**.

Bids will be received until **11:00 AM**, prevailing time on **May 2, 2019** at which time they will be publicly opened and read aloud in the first-floor conference room at the CCMUA Administration Building, 1645 Ferry Avenue, Camden, New Jersey. Subsequent to the opening of the sealed bids, the CCMUA will contact each bidding vendor to negotiate final contract terms for the Supply and Delivery of Bulk Liquid Oxygen. The CCMUA shall seek to negotiate and award the contract in accordance with the conditions set forth in N.J.S.A. 40A:11-5(3)(iii).
