Notice is hereby given that sealed bids for the Camden County Technical Schools, Pennsauken Campus 2022 HVAC Replacement and Electrical Room Addition, CCTS Bid #22-02, will be received, read and opened at the Camden County Technical Schools Board of Education, Gloucester Campus, Building 12 Board of Education Conference Room, Sicklerville, New Jersey 08081, Thursday, May 19, 2022, at 3:00 PM prevailing time by the Business Administrator / Board Secretary or his designee.

All bidders are strongly encouraged to attend a pre-bid meeting to be held at Camden County Technical Schools, Pennsauken Campus in Room 300 of the Science and Horticulture Building, 6008 Browning Road, Pennsauken, New Jersey 08109, on Friday, April 29, 2022 at 3:00 P.M., prevailing time, to fully understand the specifications and conditions of work to be done under this bid. A tour of the location will take place after the pre-bid.

The Board of Education recognizes its obligation as it pertains to the Stevens Amendment, Section 8136 of the Department of Defense Appropriations Act (P.L. 104-134, Sec.507) which requires the board of education to state clearly the percent of the total cost of this project which will be financed through funds provided under the American Rescue Plan Elementary and Secondary School Emergency Relief Fund (ARP ESSER). The Board anticipates that 100% of the total cost of the Camden County Technical Schools, Pennsauken Campus 2022 HVAC Replacement and Electrical Room Addition, CCTS Bid #22-02 Project, will be financed with Federal Funds. In addition to the legal requirements set forth herein, this project is subject to numerous requirements for federally funded contracts, which are set forth in greater detail in the Bid Documents. Contractors will be obligated to adhere to both New Jersey and federal law, and to abide by the more stringent law wherever there is conflicting authority.

Bidders are required to comply with the requirements of P.L. 1975, c.127 (N.J.A.C. 17:27) and N.J.S.A 10:5-31 et seq.

Bidders are required to comply with the requirements of P.L. 1999, c. 238, (N.J.S.A. 34:11-56.48 to 57) where applicable.

In the event of any inconsistencies between this advertisement, as published, and the bid documentation, the bid documentation shall control.
