The Project consists of rehabilitations to the CCMUA's West Collingswood Heights, Collingswood, and Berlin Borough Pump Stations and the 32<sup>nd</sup> St. CSO Facility.

Bids will be received for a single prime Contract. Bids shall be on a lump sum as indicated in the Bid Form.

Bidders are required to comply with the requirements of P.L. 1975, c.127. Bidders are required to comply with the requirements of N.J.S.A. 10;5-31 et seq. and N.J.A.C. 17:27 et seq.

Bidders are required to comply with the requirements of P.L. 1999, c. 238 (N.J.S.A. 34:11-56.25 et seq.), New Jersey State Prevailing Wage Act, where applicable.

Prospective Bidders are advised that the Project is subject to a Project Labor Agreement (PLA). The PLA will be binding upon all Contractors and Subcontractors performing on-site Project work, as defined in Article 3 of the PLA Agreement. The copy of the PLA agreement is attached to the Supplementary Conditions, Exhibit 10.

Proposals are being solicited through a "air And Open Process" in accordance with N.J.S.A 19:44A-20.4, et seq., and as such, contractors are exempt from the limitations on making political contributions under that law.

Bidders are advised that this Contract is funded in part with funds from the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure financing programs and the successful bidder must comply with the provisions of N.J.A.C. 7:22-9 for the participation of small business enterprises owned and controlled by Socially and Economically Disadvantaged (SED) individuals.

Bidders are advised the SED goal for this project is twelve percent (12%).

The Successful Bidder and Subcontractors shall hold or obtain any such licenses as required by State Statutes, and Federal and local Laws and Regulations required to lawfully complete the work described in these contract documents.

In addition, Bid must be accompanied by a consent of surety consistent with N.J.S.A. 40A: 11-22 and 2A:44-143 et seq.
