The PCFACC reserves the right to accept or reject any or all proposals submitted in the best interest of the PCFACC and it further reserves the right to waive any defect or informality in any proposal should it be in the best interest of the PCFACC.

Proposers are required to comply with the requirements of P.L. 1975, c. 127 (<u>N.J.A.C.</u> 17:27) and <u>N.J.S.A.</u> 10:5-31.
